Sir,

I SI Animesh Chakraborty of Durgachak PS lodge a complaint to the effect that on 30.12.16 around 16:55 hrs. during mobile duty received source information that one Arati Das (32) w/o Nandalal Das of Durgachak CPT Market PS- Durgachak, Dist- Purba Medinipur illegally collected huge quantity of C.S. & ID liquor for sale in her house at Durgachak CPT Market near railway crossing without any authorized license. After received information I along with force C/1317 Anil Hembram, C/765 Sanat Das and LC-116 Archana Malik left for CPT market on the house of Arati Das to pursue the information. After reaching at house of Arati Das at around 17:05 hrs. I contact with my source and as identified by the source I apprehended the person on her house in presence of her family member and LC and on search of her house found 04 (four) bottle of Country Spirit "CAPTAIN" country sprit strength 60\* UP containing 600 ml each @ Rs.55/- and one plastic jar of 05 lts. Contain full of ID liquor from her possession on her house at Durgachak CPT Market which was selling it to local people illegally on asked she failed to produce any valid documents in favour of the liquor. She gives ample time but she could not produce any document in favour of liquor. So she selling liquor illegally and causing loss of government revenue. So, I arrested her in presence of LC and maintain all formalities regarding arrest u/s 46 Bengal Excise Act. 1909 and also seized 04 (four) bottle of Country Spirit "CAPTAIN" country sprit strength 60\* UP containing 600 ml each @ Rs.55/- and one plastic jar of 05 lts. Contain full of ID liquor in presence of witnesses duly signed by them and also the accd. Arati Das.

So, there is reason to believe that Arati Das (32) w/o Nandalal Das of Durgachak CPT Market PS- Durgachak, Dist- Purba Medinipur is illegally selling the CS and ID liquor to the customers of that area. So, I produced accd. Arati Das (32) w/o Nandalal Das of Durgachak CPT Market PS- Durgachak, Dist- Purba Medinipur with seized article as per seizure list for starting a case under proper section of law.
