I SI Animesh Chakraborty of Durgachak P.S do here by lodge a complaint as suomoto to the effect that on today(03.02.17) I was performing evening patrolling duty at Durgachak P.S area with forces, vide Durgachak PS CC No. 197/17 dtd. 03.02.17 at about 18.05 hrs SI Mohan Bhattarjee Duty Officer Durgachak PS received telephonic information that some persons obstructed traffic movement on Mechada -Haldia State High Way at Bhagyabantapur under PS Durgachak. The matter was dairies by duty officer vide GDE No.93 dt. 03.02.17 and also informed the matter to O/C Durgachak PS over mobile phone, on getting such information I consulted the matter with O/C Durgachak PS who instructed me to run to the spot to look in to the matter. Accordingly I had been to Bhagyabantapur along one C/- 606 Sudipta Sahoo, HG- Debaprasad Das, L CVF -Gouri Manik with 2 C VF namely Pintu Jana and Dilip Das observations that some persons including some lady obstructed free flow of traffic at there. I tried to contract with them to get know the cause of obstructions of free flow of traffic by them. On being seen to police they became violent and started assaulting us by collecting iron rod, bamboo sticks with intend to kill us. They took way to me in a nearby pond and trough me to the water and pressed my head inside the water in order to kill me. The other forces also severally beaten by them. They also ransacked our PS vehicle bearing No. WB 30/D 0003 and tried to set fire. They also snatched away my mobile phone bearing Sim No. 9836626249 and torned our uniform also. Lastly with the help of some local people of the area we managed to rescue. At that time the said miscreants fled away from there. Those person who obstructed vehicles on State High Way one Mamtaj s/o Rahim Mallik of vill : Bhagyabantapur was identify by me who took the lead role to gather male and female persons and deliberately attack us with a intend to kill us.

So the said Mamtaj Mallick along with (18-20)other male and female persons has committed offence by assaulting on duty government officer, obstructing State High Way, damaging Government vehicle without any reason. We also treated at Haldia S.D. Hospital.

So I pray a case u/s - 147/148/149/186/332/333/341/353/325/307/379 IPC and 3/4 PDPP Act. & 18 West Bengal State High Way act 1962 and 9 MPO Act May kindly be started against Mamtaj S/O Rahim Mallik of vill Bhagyabantapur P.S Durgachak & other 18-20 male & female persons all of vill: Bhagyabantapur, PS Durgachak ,Dist: Purba Medinipur.
