In producing herewith arrested accused namely Subir Santra (22yrs) s/o Samir of Mathura, PS Manteswar, Dist. Burdwan(seller of illegal ID & F. liquor shop) along with following seized articles as per seizure list I, SI Sankar Kr. Das of Durgachak P.S. Dist. Purba Medinipur dt. here by lodged complaint against 1) Subhas Maity @ Diba 2) Shibu Maity @ Siba both s/o Lt Nani Maity both of Basudebpur, Hazra More, PS Durgachak, Dist. Purba Medinipur and above noted arrested person to the effect that on 09.03.17 myself along with C/-1317 Anil Hembran left PS to perform evening mobile duty at PS area vide Durgachak PS GDE No.346 dt.09.03.17 and C.C.No.460/17 dt.09.03.17, in course of my evening mobile duty on 09.03.17 at about 20:15hrs. received source information that one person was selling ID liquor and foren liquor illegally to the local public and younger's for gain in exchange of money. The such information informed to O/c Durgachak PS and duty office ASI Pradip Majee. The information was diarized vide Durgachak PS GDE No.455 dt.09.03.17. after that O/C directed to me more force and officer will be direct to report to you at Basudebpur, Girish More to work out the such information. After arrival of C/982 Tapan Kr. Dey, C/765 Sanat Das, L/C-116 Archana Mali arrived at Basudebpur Girish More and report to me vide C.C no.461/17 dt.09.03.17 and GD No.456 dt.09.03.17 accompanying by O/C, Durgachak PS and other superiors after that we proceed to illegal shop and adjacent godown of one Subhas Maity @ Diba and Shibu Maity @ Siba to work out the information as per order of O/C, Durgachak PS. On seeing the police team the owners of said illegal shop and some person flee away from spot. Accordingly conducted raid to the illegal shop at Basudebpur, Girish More and managed to intercepted the above noted person and arrested him. On interrogation to spot he failed to produce any valid documents and license of the shop also failed to give any satisfactory answer to me in respect of selling ID liquor and foren liquor to the local public and younger's illegally. Accordingly interrogated him and he gave his above noted identity and stated that he is seller of illegal ID liquor and foren liquor shop recoded his statement u/s 161 Cr.P.C, prepared memo of arrest and seized the following articles as alamat from the illegal liquor shop and adjacent godown of one Subhas Maity @ Diba and Shibu Maity @ Siba at Basudebpur, Girish More as shown and identified by the arrested person namely Subir Santra (22yrs) s/o Samir of Mathura, PS Manteswar, Dist. Burdwan also prepared seizure list duly signed by the arrested person and available witnesses at spot also labeled.
