In producing here with the following eight arrested accused Persons namely 1. Md Sajib (23) S/O Lt. Md Ansar Sikdar of Dakshin Kamdebpur PS Nalcity Dist Jahalo Kathi, 2. Aktar (55) S/O Lt Sabdar Hossain of Patila Khali PS & Dist Bagherhat, 3. Md Samim Hawlader (34) S/O Md Mahajel Hawlader of Madhya Barishal PS Moralganj Dist Bagherhat, 4. Md Mohiuddin (31) S/O Md Oliullah of Abdullahpur PS Begumganj Dist Nowakhali, 5. Md Amanullah (30) S/O Lt. Abdul Kalam of Char Nowapara PS Alphadanga Dist Faridpur, 6. Md Billal Hossain (43) S/O Lt Md Motaleb Mollah of Kothura Kandi PS Alphadanga Dist Faridpur, 7. Md Alamin Mollah (24) S/O Lt. Md Badsha Mollah of Astail PS Lohagera Dist Norail & 8. Md Habibur Rahaman (27) S/O Md Yusuf Sekh of Kuchia gram PS Alphadanga Dist Faridpur all of Bangladesh under arrest and along with the following seized articles. cash of Rs 9060/- (Nine thousand sixty only) in Indian currency note denomination 100 X 52, 20 X 12, 50 X 9, 500 X 6, 10 X 17 and Cash of Rs 12397/- (Twelve thousand three hundred ninety seven only) denomination 1000 X 5, 500 X 13, 100 X 7, 50 X 1, 20 X 4, 10 X 4, 5 X 3, 2 X 6 in Bangladeshi Currency note and one empty Cigarette packet of SHEIKH Co of Bangladesh. I SI Amit Deb, O/C Durgachak PS do here by lodge a written complaint to the effect that today (22.03.17) at 18.05 hrs received an information from an unknown voice over telephone that some persons were gathered at Akash Ganga Complex near Manjushree more, perhaps they are inhabitants of Bangladesh. He needs Police interference but he did not disclose his identity and nothing more. I noted it in to the GDE vide Durgachak PS GDE No.953 dt.22.03.17. I informed the matter to the CI Mahishadal, SDPO Haldia and Addl SP Haldia listen to their instructions. Then Myself along with C/1673 Ramsankar Ponda, C/1369 Mohit Kr Shit, C/982 Tapan Kumar Dey and LC/116 Archana Malik left for Manjushree more vide Durgachak PS GDE No.954 dt.22.03.17 and CC No.586/17 to work out the information. At 18.35 hrs we reached at Akash Ganga Complex at Manjushree more and found that the above eight persons were gossiping amongst themselves standing in front of the ATM Counter of Axis Bank being question they introduced themselves as above. As they are the inhabitants of Bangladesh so I asked them to produce their Passport/Visa or any other documents in support of their entry and stay in India but they fail to produce any Passport/visa or any other documents in support of their presence in India. More over they made different statement in different time. As they were liable U/S 14(C) The Foreigners Act So I took them into custody, Searched them and could seized cash of Rs 9060/- (Nine thousand sixty only) in Indian currency note denomination 100 X 52, 20 X 12, 50 X 9, 500 X 6, 10 X 17 and Cash of Rs 12397/- (Twelve thousand three hundred ninety seven only) denomination 1000 X 5, 500 X 13, 100 X 7, 50 X 1, 20 X 4, 10 X 4, 5 X 3, 2 X 6 in Bangladeshi Currency note and one empty Cigarette packet of SHEIKH Co of Bangladesh under proper seizure list in presence of witnesses, and duly signed by them. Arrest was effected by issuing Memo of arrest and I narrated the ground of arrest before them at the time of arrest. Intimation is being sent to their house about their arrest. I treated them medically at Haldia SD Hospital. On return to the PS I started Durgachak PS C/No. 46/17 dt. 22.03.17 U/S 14 (C) The Foreigners Act as suomoto, SI Sankar Das will please investigate the case, Took all informative actions.
