I, NABA KUMAR DAS, S/O:- Lt. Bijoy Krishna Das, residing at Vill. + P.O. + P.S.:-
Durgachak, Dist.:- Purba Medinipur, Pin.:- 721602, West Bengal, I beg to stated as follows:-

- 01) That I am a very simple, honest and law bounded lady and residing at the above mentioned address since long with my family.
- 02) That today i.e. on 07/05/2017 at about 11:00 a.m. when I was going to my brick field at Ananda-O-Krishnachak during my journey when I was reached to the railway crossing at Piyangbada suddenly the below mentioned accused person along with his other associates were obstruct my way and stooped me.
- 03) That after that the below mentioned named accused persons were starts abusing me with filthy languages and after hearing this when I protest them then they were starts assaulting me by fist and blows and the accused no.:- 01 has assaulted me by a bamboo sticks over my head but by luck I put my hand and I sustained pain and swelling injury over my right wrist.
- 04) That after that the other associated were caught me and the accused namely **CHINMOY DAS** has snatched my hand bag and my said hand bag has contained a sum of Rs. 20,7000/- (Rupees Two Lakhs Seven Thousand Only) and other valuable documents.
- 05) That after hearing my hue and cry some local villagers were came to spot and by seeing them to came to the spot all the below mentioned accused persons were ran away.
- 06) That during leaving the spot all the below mentioned named accused persons were threatened me that if I will tell the said facts then they will killed me and they also threatened me that it was just starts they will be looted my Brick Field at Ananda-O-Krishnachak and make harms by different way.
- 07) That after that I have got treatment by the Doctor.
- 08) That due to the above said incident I became very scared.
- 09) That I humbly prayed before You that please take a necessary action against all the below mentioned named accused persons as soon as possible as my life is in danger from all the below mentioned named accused persons.

In the above circumstances I humbly prayed before you that please take necessary legal action against all the below mentioned named accused persons by which way I will be able to live safely and move freely and I shall got justice as per law.
