1. One old and used Honda Shine black colour motor cycle having number plate bearing registration No. WB-14L/2583 Engine No. JC36E7072192 and Chesis No. ME4JC36JEC7048436
 2. One old and used Hero Honda splendor Pro black & Blue colour motor cycle having Engine No. HA10EH89D19053 and Chesis No. MBGHA10ADB901523
 3. One old and used Bajaj Discover black & Red colour motor cycle having Engine No. JZUDUL54873 and Chesis No. MD2DSJZZUPL39378.
 4. One old and used Honda Shine deep Pink colour motor cycle having Engine No. JC36E9129925 and Chesis No. ME4JC366M78064447

I ASI Dilip Mondal of Durgachak PS do here by lodged a written complaint against the following three accused persons namely.

1. Sabud Bhangl(27) S/O Idrish Bhangl of Uporjaba PS Garbeta
2. Sk.Sabir . @ Raju @ Boba (25) S/O Lt Sk. Lokman of Chatna Masjidpara PS Chatna, Bankura
3. Suraj Ali Khan @ Gera @ Sahil @ Nawab (30) S/O Lt Maitab Ali Khan of Rangamati, Chandrokona Road, PS Garbeta to the effect that today (07.05.17) at 16.45 hrs leading to the statement of the above three accused persons who are in Police Custody in C/W Durgachak PS C/No. 35/17 dt.02.03.17 U/S 379 IPC myself along with other officer and force had been to the Patikhali under PS Durgachak as shown by the above three accused I could found that the above four motor cycles are kept in a abandoned quater of HFC bearing Q/No.33 falls in the mouza Patikhali W/No.IX under Haldia Municipality PS Durgachak. I search for the owners of those motor cycles. None turned up. On demand all three Police custody accused persons were fails to produce any valid documents/Challan/Receipt in support of possession of those four motor cycles and they made different statement in different time. They stated that they have collect those four motor cycles by committing theft in various places in various time and kept those motor cycles conceal in that abandoned quater with a view to sold those motor cycles for wrongful gain. I seized those above four motor cycles as suspicious under proper seizure List in presence of the witnesses duly signed by them. All the above three accused persons were also stated that they have already sold a good number of motor cycles in various place after committing theft earlier. During investigation it could be learnt that accused Sk Sabir was involved in a good number of cases. Three Warrant of Arrest are laying pending against accused Sk Sabir at Chatna PS district Bankura in C/W Chatna PS C/No.93/14 dt.09.04.14 U/S 25 Arms Act, C/No.54/11 dt.21.02.11 U/S 379 IPC and C/No.133/11 dt.17.11.11 U/S 379/411 IPC. Accused Suraj Ali Khan was arrested earlier in C/W Tamiuk PS C/No. 79/17 dt.28.01.17 U/S 380 IPC started over the complaint of a motor cycle theft. So it could be ascertain that they were habitually dealing in stolen motor Cycle and other stolen properties and assisting in concealment of stolen motor cycles and other stolen properties. So all the above three accused persons are liable U/S 413/414 IPC.

Hence under the above circumstances a case U/S 413/414 IPC may kindly be started against them and oblige.
