

Jasimuddin of Vill.- Bhagyabantapur, P.O- Khanjanchak, Ps.- Durgachak, Dist.- Purba Medinipur with sealed (i) 06 bottles Bindash Country Spirit in contains 600 ml/bottle @ Rs/- 65 each & 05 litre I.D liquor @ Rs/- 50/litre, Total Value Rs.= 640/-

I, St. Soumya Paul, presently posted at Durgachak Ps. do here by lodged a written complaint to the effect that today (28.05.2017) in course of Evening R.T Mobile duty with C/606 Sudipta Sahoo & C/765 Sanat Kr. Das under Ps. area, at about 18:45 hrs. I received a telephonic information from my reliable sources that one person namely Sk. Samsuddin S/o- Lt. Sk. Jasimuddin of Vill.- Bhagyabantapur, Ps.- Durgachak is selling liquors illegally from one shop at Girish More of Basudevpur under Durgachak Ps. since few years.


Accordingly myself along with force reached at Girish More under Durgachak Ps. at the shop (Gumti) of alleged Sk. Samsuddin at about 19:15 hrs. and found that the alleged Sk. Samsuddin is selling liquors illegally from one shop at Girish More of Basudevpur under Durgachak Ps. Seeing Police Personnel the alleged Sk. Samsuddin was tried to fled away from the spot but we caught him red handed. On being asked, he could not produce any valid documents in favor of those liquors. There after I seized the above noted sealed 06 bottles Bindash Country Spirit in contains 600 ml/bottle @ Rs/- 65 each with one nylon bag & 05 litre I.D liquor @ Rs/- 50/litre in a white Jerkin, Total Value Rs.= 640/- under proper seizure list from the possession of alleged person duly signed by the witnesses. I arrested him and he confesses that he is selling liquors illegally from his shop since long.

Under the above fact and circumstances, I therefore pray that a case may kindly be started U/S- 46(A) B.E. Act against alleged Sk. Samsuddin S/o- Lt. Sk. Jasimuddin of Vill.- Bhagyabantapur, Ps.- Durgachak, Dist.- Purba Medinipur.
