Sub: Prayer for start a case u/s 399/402 IPC

In producing here with the arrest accused namely – 1) Bapan Das(24yrs) s/o Bablu Das of vill. Basudebpur, PS Durgachak, 2) Santu Maity(21yrs) s/o Naran Chandra Maity of Raghunsthchak, PS Durgachak and 3) Palas Mondal s/o Dilip Mondal of Paranchak, PS Bhabanipur all of Dist. Purba Medinipur along with all seized articles as per seizure list. I S.I. Soumya Paul of Durgachak PS beg to report that on the night of 29/30.05.17 at about 01:05hrs in course of night patrolling duty received secret source information that a gang of criminal (approx 8/9 persons) assembled at HPL Link Road near food park in order to commit dacoity/rubbery nearby house or road. After receiving of the information I informed the matter over telephone to O/C, Durgachak PS, as per his direction myself along with C/1663 Sk Saifuddin, C/606 Sudipta Sahoo vide Durgachak PS C.C. No.1768/17 dtd.29.05.17 and G.D No.1892 dtd.29.05.17 for that area to work out the information and to prevent the commission of crime. We silently and carefully reached near Food Park at HPL Link Road and watch from a distance that a group of people 8/9 assembled suspiciously at Food Park at HPL Link Road, they talking among themselves in whispering manner. They assembling in suspicious manner at such dead hours of night I ordered my force to cordon them subsequently we surrounded them from all side but on seeing police they tried to fled away but after a hot chase we able to apprehend three of them while the others managed to escape taking advantage of darkness. We disclosed our identity and interrogated the apprehended the suspected three persons when they disclosed their identity as above. While searching their persons we recovered one iron rod, one wooden battam and one cycle chain from their possession and on further interrogation they disclosed that they along with Masum, Asgar, Mana all of Bhagyabantapur and two unknown others assembled there in order to commit road robbery/dacoity at HPL Link Raod. So there is reason to believe that they all are assembled there with a preparation in order to commit dacoity as per prior information received. Then I arrested the accused 1) Bapan Das(24yrs) s/o Bablu Das of vill. Basudebpur, PS Durgachak, 2) Santu Maity(21yrs) s/o Naran Chandra Maity of Raghunsthchak, PS Durgachak and 3) Palas Mondal s/o Dilip Mondal of Paranchak, PS Bhabanipur all of Dist. Purba Medinipur in this case and seized the above noted articles from their possession as per seizure list prepare in presence of witnesses duly signed by them.

In the above fact and circumstances I pray that a case may kindly be started against 1) Bapan Das(24yrs) s/o Bablu Das of vill. Basudebpur, PS Durgachak, 2) Santu Maity(21yrs) s/o Naran Chandra Maity of Raghunsthchak, PS Durgachak and 3) Palas Mondal s/o Dilip Mondal of Paranchak, PS Bhabanipur all of Dist. Purba Medinipur and other 5 persons u/s 399/402 IPC and oblige.
