Dear Sir,

I do hereby lodged a complaint empowered by the Electricity Act 2003 to the effect that Sk. Rejaul, S/o-sk. Habib Ali, Vill- Patharberia, PO- Dorojoynagar, PS- Durgachak, Dist- Purba Medinipur have committed theft of Electricity u/s 135 of the Electricity Act 2003 read with amendment act 2007 as stated hereunder.

On 02.06.2017 about 01.25 pm I, Goutam Barua (A.E & S.M) along with Dibyendu Sekhar Bhunia (D.E & S&LP) of Tamluk Regional Office, Arjun Bera (L.M) and Bholanath Duley (TSH) of Chaitanyapur CCC & Other official went to domestic premises of Sk. Rejaul, S/o-sk. Habib Ali, Vill- Patharberia, PO- Dorojoynagar, PS- Durgachak, Dist- Purba Medinipur.

During inspection it was found that Sk. Rejaul, S/o-s. Habib Ali was consuming electricity dishonestly by the way of direct hooking from nearby LTOH line through PVC wire for domestic purpose at a tune of load 0.35 KVA, causing loss of revenue to WBSEDCL.

As the theft of electricity was detected, the unauthorized wire was disconnected and removed from the L.T line and there after some portion of hooking wire, two core PVC cable 10 metre. Approx of white colour along with hooking device was seized in the presence of witnesses under a memo of seizure list and their signature duly obtained on the seizure list. The above seized articles were packed and labelled and signature of witnesses also obtained on the label. I also prepared an inspection report at site and duly signed by the witnesses. I also approach to accused person for signature in the seizure list & inspection report but he refused to sign and I also approached to produce documentary evidence related to ownership of the house but also refused to produce it. From local enquiry it is learnt that ownership of the house belongs to Sk. Rejaul, S/o-sk. Habib Ali. After completion of inspection we left the spot at 01.45 PM.

Thus the Sk. Rejaul, S/o-sk. Habib Ali, Vill- Patharberia, PO- Dorojoynagar, PS- Durgachak, Dist- Purba Medinipur has committed offence U/S 135(i)(a) of the Electricity Act 2003 read with Amendment act 2007.

Under this circumstance you are requested to take cognizance of this complaint & treated the same as F.I.R in view of theft of electricity.
