Sir,

In producing herewith one arrested accused person named Tapan Jana, age 34 yrs approx, s/o- Sushil, of Gobindabasan, P.S Digha Mohana Coastal, Purba MDP, along with the following seized articles

1. 03 Plastic bottles of SUN Country Spirit, each bottle containing 600 ml, and cost Rs-65/-
2. 02 Glass bottles of SUN Country Spirit, each bottle containing 600 ml, and cost Rs-65/-
3. 02 Glass bottles of Mac Dowell No1 Celebration RUM, each containing 180 ml, and cost Rs-90/-

The fact is such that I A.S.I Nilratan Pradhan, today on 06/05/17 at approx 20:35 hrs while performing special raid duty, got a secret source information that one person named Tapan Jana, age 34 yrs approx, s/o- Sushil, of Gobindabasan, P.S Digha Mohana Coastal, Purba MDP, is selling several foreign liquors and country spirit illegally at Sea Hawk Ghola, Sea beach under Gobindabasan Mouza. In that circumstances I after informing the matter to my superiors, proceeded towards Sea Hawk Ghola Sea beach, along with the force (C/-1439 Tapas Sarkar, C/-1077 Jiten Soren, C/- 1110 Sukanta Mahato, vide CC No- 845, Dt- 3/06/17) who were also engaged in the same duty, to work out the information, and after reaching at the Sea Hawk Ghola, Sea beach side, under Gobindabasan mouza, as identified by the secret source at approx 21:15 hrs, I found the above noted person is selling above noted articles beside the sea beach. Whatever I detain the said Tapan Jana, and asked him to produce license in respect of his possession and selling of those articles, but he failed to show any such thing, and also confessed his guilt that he is possessing and selling those article without any license. In the above facts and circumstances, I seized above mentioned articles from the exclusive possession of Tapan Jana, under proper seizure list duly signed by the local witnesses, and as he violates the section 46A(c) of Bengal Excise Act 1909 arrested him under proper arrest memo after maintaining all formalities. All the seized items has been labeled and sealed properly. (The total approximate value of the seized articles are Rs-505/-). During interrogation the said Tapan Jana discloses his name and address as Tapan Jana, age 34 yrs approx, s/o- Sushil, of Gobindabasan, P.S Digha Mohana Coastal, Purba MDP. So I brought him under arrest to the P.S along with the seized articles.

So I pray necessary action may kindly be taken by registering a specific case against the arrested accused Tapan Jana, age 34 yrs approx, s/o- Sushil, of Gobindabasan, P.S Digha Mohana Coastal, Purba MDP under proper section of Law.
