I S.I Sanjib Dutta, O/C Digha Mohana Coastal P.S do hereby lodged a written suomoto complain against the following 06 arrested accused persons named, i) Santanu Sahoo(25), s/o- Pranab Kr Sahoo, of Alankarpur, P.S Digha Mohana Coastal, Purba MDP, ii) Anup Das(25), s/o- Gyenendra, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, iii) Bablu Jana(40), s/o- Lt Bhim Charan, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, iv) Rajesh Das(33), s/o- Swapan, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, v) Ranadhir Nayek(34), s/o- Santosh, of Maitrapur, P.S Digha Mohana Coastal, Purba MDP, vi) Ashoke Kr Bhanja(62), s/o- Lt Jhareshwar, of Maitrapur, P.S Digha Mohana Coastal, Purba MDP, and 05 other not arrested but involved accused persons named vii) Anupam Das, s/o- Gyenendra, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, viii) Amit Maity, s/o- Ashim, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, ix) Chandan @ Shibu Pauro, s/o- Ashim Pauro, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, x) Rabin Maity, s/o- Lt Ramesh Ch, of Alankarpur, P.S Digha Mohana Coastal, Purba MDP, xi) Subhodip Karan, s/o- Ashim, of Alankarpur, P.S Digha Mohana Coastal, Purba MDP, and approx 250 other involved unknown persons.

The fact is such that today on 24.06.17 at approx 19:05 hrs received telephonic information that approx 300 persons from Alankarpur, Dahadaya, Maitrapur, Haropur and other surrounding areas obstructed NH116B(National Highway) at Alankarpur Bazar in protest against the RTA death of one person named Sanjib Maity, s/o- Fanibhusan, of Alankarpur, P.S Digha Mohana Coastal, Purba MDP, which refers to Digha Mohana Coastal P.S U/D Case No- 18/17, Dt:- 23/06/17, and specific case No- 33/17, Dt:- 24/06/17, u/s- 279/304A of IPC. Whatever after getting such information I inform the matter to my superiors and myself along with available force and officers(ASI Saidul Rahaman, ASI Nilratan Pradhan, C/- 379 Sk Rasiduddin, C/- 516 Shyamal Chalak, C/-1110 Sukanta Mahato, C/- 13 Rabiul Hossein) left the P.S vide DMC P.S GDE No- 687, Dt:- 24/06/17, for the Alankarpur Bazar and arrive at the said place at around 19:45 hrs. I also took all informative action to mobilize force from my P.S who were engaged in M/Cycle mobile duty and Vehicle Mobile duty vide CC No- 963/17, Dt:- 24/06/17, and CC NO- 964/17, Dt:- 24/06/17, and also sought for reinforcement from the bordering P.Ss. after the arrival I found a huge furious mob comprising 300 or may be above, showing agitation on the middle of the NH116B, by obstructing the same with wooden log and wooden bench, as result huge no of both Digha & Contai bound public and private vehicles along with several passengers comprising, male female, child got stranded. In the above facts and circumstances I requested the assembled mob in several times to withdraw their obstruction for the free flow of the traffic, but my request yield no response, rather the said unruly mob started to throw provocative and slang languages towards the police party present there. They even ask the police party to leave the place otherwise they attack the police party. In that scenario it has been

observed that the obstruction of road crosses the tolerable time limit, ie till 21.25, and the mob become unruly, so I declare the mob as unlawful, and ordered them to disperse themselves. On hearing my command a portion of the mob become more furious and started to assault the police force by lathi (tree branches), by pelting stones and broken bricks, and even started to throw glass bottles, as a result some police personal including one officer got serious injury over their persons, some of the unruly mob caught the collar of the police personnel also, and assaulted them with fist and blow, snatched wrist watch from the C/- 1561 Kalipada Das. In the mean time after the arrival of the reinforcement we the police party chase the unruly mob to overpower them and accordingly arrested the above noted 06 persons who belong to the said unruly assembled mob, while the others became managed to escape/flee away. After that I seized i) 05 pieces of lathi (Tree branches), ii) 25 pieces of broken bricks, iii) 26 pieces of stones, iv) 01 pieces of wooden log, and v) one long wooden table (bench), from the P.O/Over NH116B under proper seizure list duly signed by the witnesses, and later on become able to normalize the free flow of traffic. Whatever I brought the above noted 06 arrested accused person to the P.S and upon interrogation they disclosed the following names of the persons who participated in the

unlawful assembly are i) Anuram Das, s/o- Gyanendra, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, ii) Amit Maity, s/o- Sudhir, of Alankarpur, P.S Digha Mohana Coastal, Purba MDP iii) Chandan @ Shibu Payra, s/o- Manu Payra, of Dahadaya, P.S Digha Mohana Coastal, Purba MDP, iv) Rabin Maity, s/o- Lt Ramesh Ch. of Alankarpur, P.S Digha Mohana Coastal, Purba MDP, v) Subhodip Karan, s/o- Ashim, of Alankarpur, P.S Digha Mohana Coastal, Purba MDP, and approx 250 or may be more unknown persons.

In the above facts and circumstances I do hereby register a specific case against the above noted persons vide Digha Mohana Coastal P.S Case No- 34/17, Dt:- 25/06/17, u/s- 147/149/186/283/332/333/353/379 of IPC and 8B of National Highway Act 1956.
