Sir,

I ASI Pradip Majee of Durgachak PS lodge a complaint to the effect that on 13.12.16 around 06:45 hrs. during morning mobile duty received source information that one Smt. Panchami Jana (35) w/o Lt. Rabindranath Jana @ Rabi of Durgachak Colony "G-105" Block PS- Durgachak Dist - Purba Medinipur illegally collected huge quantity of ID liquor and CS for sale in her hut shop at Durgachak CPT market back side of the CPT market bus stand without any authorized license. After received information I along with C/1673 Ramsankar Panda LC/ 1727 Ganga Barman Jana and 02 CVF left for Durgachak CPT market to pursue the information. After reaching at Durgachak CPT market at around 07:05 hrs. I contact with my source and as identified by the source I apprehended the person and found 05 ltrs. of ID liquor in a plastic jariken and 06 bottle of Country Sprite "CAPTAIN" strength 60* UP measure 600 ml each @ Rs. 55/- from her possession which was selling it to local people illegally on asked she failed to produce any valid documents in favour of the liquor. So, I arrested her u/s 50 Cr.P.C. maintain all formalities and also seized 05 ltrs. ID liquor and 06 bottle of CS in presence of witnesses duly signed by them and also the accd. Smt. Panchami Jana.

So, there is reason to believe that Smt. Panchami Jana(30) w/o Lt. Rabindranath Jana @ Rabi of Durgachak Colony "G-105" Block PS- Durgachak Dist - Purba Medinipur is illegally selling the ID liquor to the customers of that area. So, I produced accd. Smt. Panchami Jana with seized article as per seizure list for starting a case under proper section of law.
