Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Bhagwan Patra, S/O - Lt Harekrishna Patra, a permanent resident of Vill- & P.O -Erenda, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 04.04.2017 at about 12:45 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr Chakraborty, SO both are of (S&LP), Contai Division Office along with Sri Soumen Mondal, AE & SM Egra CCC, Sri Sudip Sasmal, SAE (E), Egra CCC, Sri Bappa Mondal, TSH, Egra CCC and others had been to the village-Erenda under PS Egra for routine inspection purpose. During inspection it was found that Sri Bhagwan Patra, S/O - Lt Harekrishna Patra was consuming electricity dishonestly in his Agricultural premises unauthorisedly by way of direct hooking through 3/20 SWG white coloured PVC coated aluminium conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 1.17 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 01 (one) number single core 660/1100 volt grade 3/20 SWG white coloured PVC coated aluminium conductor of length 08 (eight) meter (approx) along with hooking device as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Bhagwan Patra, S/O - Lt Harekrishna Patra acknowledged the same but refused to sign in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 01:15 PM.

Thus the accused Sri Bhagwan Patra, S/O - Lt Harekrishna Patra, Vill & P.O - Erenda, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
