Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Samir Ranjan Das, S/O- Harekrishna Das of Vill: & P.O- Chhatri, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 02.06.2017 at about 01:30 PM, I, Sri Soumen Mondal, Egra CCC, along with Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, Sri Bikash Maity, LM, Egra CCC and others had been to the Vill: Chhatri, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Samir Ranjan Das, S/O- Harekrishna Das of Vill: Chhatri, P.O- Chhatri, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Samir Ranjan Das, S/O- Harekrishna Das of Vill: Chhatri, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of tampering the energy meter causing damage to the display of the energy meter vide Meter No: B1511604 for not recording and also not to display the actual energy consumption in respect of Consumer Id No: 200318801, in view of his wrongful gain as well as causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and one Bentec make 5-30 Amp, static energy meter vide sl no- B1511604 along with 1 no tampered poly carbonate seal vide Sl No- XE4401648 and one yellow card in the name of Sri Samir Ranjan Das were seized under memo of seizure list in presence of Sri Harekrishna Das S/O Lt. Gobinda Prasad Das and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of representative of the Consumer i.e. Sri Harekrishna Das S/O Lt. Gobinda Prasad Das (father of accused) and witness and signature of witnesses and representative of the consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:00 PM.

Thus Sri Samir Ranjan Das, S/O- Harekrishna Das of Vill: Chhatri, P.O- Chhatri, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
