Sir,

In producing herewith arrested accused Netai Shit (42) S/O-Ananta Kr. Shit of Uttar Daudpur, P.S -Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Bibek Banerjee of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (07.06.17) at 04:45 hrs myself along with C/1337 Sk Kutubuddib, C/842 Abdul Khalek Khan and C/1648 Haripada Mahanty of Egra P.S vide C.C. No-1228/17 dt-06.06.17 as per secret source information reached at Uttar Daudpur under Egra PS and held raid in the house cum shop of Netai Shit (42) S/O-Ananta Kr. Shit of Uttar Daudpur, Dist-Purba Medinipur and found that he is selling Sun country Spirit illegally. On being asked he failed to produce any valid documents/ license of the above mentioned possessed Sun Country Spirit. On being asked the accused person stated that he is running this business since long having no valid license as well as he confessed his guilt.

Accordingly seized 10 (Ten) sealed bottles of Sun country Spirit each bottle contains 600 ml x 10=6000 ml and each bottle cost of Rs-65 x 10 = Rs 650/- (Rupees Six Hundred fifty) only with one Nylon Bag as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry I have been learnt that the above noted accused person selling Sun Country Spirit illegally since long.

So, I do hereby lodge a written complaint against above mentioned Netai Shit (42) S/O-Ananta Kr. Shit of Uttar Daudpur, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act-1909 with a request for starting a case.
