I S.I Krishnendu Pradhan, O/C Egra PS do here by lodge complaint as Suo Moto against Satyajit Adhikari S/O Brajendra Nandan Adhikari of Solpatia, A/P Mirzapur; PS Egra, Dist. Purba Medinipur, from Kudi – Ramnagar pitch road one side of mouja Jalchhatra, under PS Egra, obstructing the public way who was stacking other article (wooden Log) on Egra – Contai pitch road in front of the house of the above noted person which is obstructing the portion public way rashly and negligently as to on danger human life as the personal safety of the public.

The fact of the case in brief is that on 04.03.2017 in course of my mobile duty I noticed that some person is doing business of supplying wooden log and keeping the materials at one side of the state High way on Kudi – Ramnagar pitch road at Jalchhatra, which is obstructing the public way and as a result the road was becoming narrower which became dangerous for the public safety on the road. Considering the dangerous of the safety as per instruction of SP, Purba Medinipur awareness and making was done previously on 01.02.2017 to remove the same by the respective party. But they did not remove the same.

On enquiry it could be learnt that one Satyajit Adhikari S/O Brajendra Nandan Adhikari of Solpatia, A/P Mirzapur, PS Egra, Dist. Purba Medinipur, is doing his business of supplying (wooden log) and keeping the wooden log by the side of Kudi – Ramnagar Pitch road at Jalchhatra, Which was obstructing the roads and on danger human life of the public. He had committed offence U/S - 283/336 IPC.

I examined so many villagers and took photograph of the place, but it was impossible to seize those huge quantity of materials, I have no man power or JCB for the removal work at that time.

So, I do lodge complaint as suo-moto against Satyajit Adhikari S/O Brajendra Nandan Adhikari of Solpatia, A/P Mirzapur, PS Egra, Dist. Purba Medinipur, and start a case U/S - 283/336 IPC and investigation and ASI Asim Kumar Maity will investigation the case.
