Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Dipak Mondal, S/O- Shyamsundar Mondal of Vill: Bamunia, P.O- Paniparul, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 09.03.2017 at about 02:30 PM, I, Sri Sudipta Rong, AE & SM, Chorepalia CCC, along with Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, Sri Ratan Bhunia, SAE (E), Chorepalia CCC and Sri Raju Hazra, LM, Chorepalia CCC had been to the Vill: Bamunia, P.S-Egra for routine inspection purpose. At first we went to the Agriculture premises Sri Dipak Mondal, S/O- Shyamsundar Mondal of Vill: Bamunia, P.O- Paniparul, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Dipak Mondal, S/O- Shyamsundar Mondal of Vill: Bamunia consuming electricity unauthorisedly by way of tampering the service cable for bypassing the energy meter unauthorisedly in respect of Consumer Id No: 201948417, Meter No: GF733473, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 4.380 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 3 (three) nos. separated single core tampered 10 sq mm with all are of white colour PVC coated aluminium conductor of length 1.5 (one & half) meter each approx as a part of the service cable used to run the agricultural pump-motor set unauthorisedly for bypassing the energy meter as a sample were seized under memo of seizure list in presence of consumer and witnesses and duly signed by the witnesses as Sri Dipak Mondal, S/O- Shyamsundar Mondal refused to sign on the same. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:50 PM.

Thus Sri Dipak Mondal, S/O- Shyamsundar Mondal of Vill: Bamunia, P.O- Paniparul, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (ii)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
