


Sir,

In producing herewith the accused (i) Santanu Maity @ Gaba(35) S/O- Gagan Maity of Srikrishnapur, PS-Dantan, (ii) Subhas Dinda(37) S/O -Lt. Haracharan Dinda of Sitapur, PO+PS-Mohanpur, (iii) Amlt Shit @ Bapi @ Bathu(31) S/O -Subal Shit of Radhaballavpur, PO-Chhoto Srikrishnapur, PS-Dantan (iv) Ranjan Raj(26) S/O- Susil Raj @ Hari Raj of Rangsetia, PO-Jenkapur, PS-Dantan all of Dist-Paschim Medinipur (v) Bhaktipada Dash @ Bumba(48) S/O-Lt. Srinibhash Dash of Vill+PO-Alangiri, PS-Egra, Dist-Purba Medinipur along with seizure list, seize articles, arrest memo. I SI Deb Prasad Samanta of Egra PS do hereby lodge a complaint against the above noted arrested accused persons. I am to report that on 28.03.17 at about 23:45 hrs received a information from PS that some miscreants have been assembled at Chandalda under this PS and they are whispering in a low voice inside a vehicle preparing to commit dacoity near by village. Myself along with force C/1193 Dilip Kr. Bar, C/1648 Haripada Mahanty & NVF Kalachand Jana vide Egra PS CC No 546/17 date 28.03.17 left for workout the information. I also informed another mobile party headed by ASI Tapas Kr. Das with force C/ 747 Pranajit Dey, C/401 Prabir Kr. Das & NVF-SK Ekram Vide Egra PS CC No 547/17 Dated 28.03.17 who is engaged night mobile duty to move towards Chandalda. We used PS vehicle No-WB-42S/1500 and Vehicle No-WB-29/5034 (1/2 Toner) and reached at Chandalda at 00:35 hrs(29.03.17) and then we rushed to Chandalda and found from a distance some persons were assembled and talking in a low voice. We try to called local villagers, but the place is solitary and none found. Then we police party gheraowed those persons finding the police personnel they tried to flee away but we managed to apprehend the above 05(Five) persons and conducted search in presence of accompany police personnel during search one 12 inches Bhojali found in possession of Santanu Maity @ Gaba and one 09 inch Knife was found in possession of Ranjan Raj also found and seized from the spot one black white colour scorio Bearing No OR-01L/5759, and seized one 30 inches sabal and 02(Two) pieces iron rod each length 30 inches also found the above noted articles from the vehicle. On being asked they disclosed their identify as noted above during interrogation the above noted accused persons confessed that they were assembled there and were preparing to commit house dacoity in near by village. I prepared seizure list of those articles duly sign by the witnesses and also prepared arrest memo. Arrested the above noted 05(Five) accused persons and inform them ground of arrest.

Hence I request to start a case U/S 399/402 IPC against the above noted accused persons.
