Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Bhupati Charan Jana, S/O - Lt Gopal Jana is permanent resident of Vill- & P.O -Bartana, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 17.03.2017 I, Sri Soumen Mondal, Egra CCC along with Sri Bikash Maity, LM, Egra CCC, Sri Bappa Mondal, TSH Egra CCC and others had been to the village- Bartana for routine inspection purpose. At first we entered into the domestic premises of Sri Bhupati Charan Jana, S/O - Lt Gopal Jana at about 12.10 PM and during inspection it was found that Sri Bhupati Charan Jana was consuming electricity dishonestly in his Domestic premises unauthorisedly by the way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.5 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 (two) nos separated single core one whitish & one Black coloured PVC coated 4 sq mm, aluminium conductor of length two meter each (approx) along with hooking device used to run the electrical appliances for domestic purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Bhupati Charan Jana acknowledged the same by putting his signature on the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 12.30 PM.

Thus the accused Sri Bhupati Charan Jana, S/O - Lt Gopal Jana, Vill - Bartana, P.O -Bartana, , P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
