Sir,

In producing herewith the following seized articles as per seizure list duly signed by witnesses, I SI Bibek Banerjee of Egra P.S do hereby lodge a complaint after returning at P.S to the effect that today (21.02.17) at 20:15 hrs myself along with C/1141 Bharat Ghosh, C/468 Sandip Kumar Maity & C/401 Prabir Kr. Das all of Egra P.S vide C.C. No 440/17 dt-21.02.17 as per secret source information reached at Dobandhi Bus Stand under Egra PS and held raid in the shop of Sanatan Jana S/O Kanailal Jana of Khejurda, PS Egra, Dist Purba Medinipur and found that he was selling Foreign liquor illegally. On seeing Police Party the above noted accused person fled away from his shop.

Accordingly I have seized (i)03(three)bottles Officer Choice each bottle containing 180ml each bottle rupees 85/-x 03 =Rs.-255/- (ii)02(Two)bottles Officer Choice Blue Whisky each bottle containing 180ml each bottle rupees 130/-x 02 =Rs.-260/- (iii)01(One)bottle Old Monk XXX Rum containing 180ml Rs. 90/- (iv) 01(One)bottle Imperial Blue Whisky containing 180ml Rs. 120/- (v) 01(One)bottle Mc Dowell's No 1 XXX Rum containing 375ml Rs. 180/- as per seizure list duly signed by witnesses. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person illegally selling Foreign liquor since long. Total cost of Rs. 905/- (Rupees Nine hundred Five) only.

So, I do hereby lodge a written complaint against above mentioned Sanatan Jana S/O-Kanailal Jana of Khejurda, P.S-Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
