Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Pijush Jana, S/O - Sri Narayan Jana, a permanent resident of Vill+P.O-Chatla, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 21.02.2017 at about 04.40 PM I, Sri Sudipta Rong, AE & SM of Chorepalia CCC, alongwith Sir Ratan Bhunia, SAE (E), Chorepalia CCC, Raju Hazra, LM of Chorepalia CCC and other had been to the village- Chatla for routine inspection purpose and found that Sri Pijush Jana, S/O - Sri Narayan Jana was consuming electricity dishonestly in his Agricultural premises unauthorisedly by way of direct hooking from the nearby LT mains of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 4.38 KVA.

As theft of electricity was detected during inspection so the unauthorized line was disconnected & removed from our LT source and some portion of 03(three) nos 06 sq mm single core red colour PVC coated aluminium conductor of length 02(two) meter approx each along with hooking arrangement were seized under memo of seizure list in the presence of witnesses of WBSEDCL respect person and their signature is also duly obtained in the seizure list, inspection and label. The above seized materials duly packed and labeled at the inspection site. After completion of inspection, the inspection team left the aforesaid premises at about 05.10 PM.

Thus the accused Sri Pijush Jana, S/O- Sri Narayan Jana, a permanent resident of Vill+P.O-Chatla, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
