Sir,

In producing herewith 01 (One) arrested male accused person namely Ratan Pal (40Years) S/O Sri Panchanan Pal of village Hatiyari, P.O. Balageria, P.S- Marishda, Dist-Purba Medinipur in custody under proper Memo of Arrest of seized articles as per seizure list duly signed by witnesses and accused person.

I, SI Bibek Banerjee of Egra PS do hereby lodge a complaint after returning at PS, against above noted arrested accused person, to the effect that today i.e. 22.02.2017 at Morning myself along with C/ 1141 Bharat Chandra Ghosh, C/468 Sandip Kumar Maity and C/401 Prabir Das all of Egra PS were performing special morning Mobile Duty in c/w Madhyamik Examination 2017, vide C.C. No- 443/17 dt-22.02.17, while myself along with force reached at Bhabanichak High School we noticed that the one Xerox shop is open and photocopy also done by the shop owner, near Bhabanichak High School.

We request him to stop illegal work and asked him to closed the shop, but he become furious and he did not pay any heed of my word. I also remember him that Sri Rajat Kanti Biswas, W.B.C.S (Exe.) Egra Sub-divisional Magistrate order and promulgate U/S 144 Cr.P.C 1973 that assembly of 5 or more persons within 100 meters of the examination venues is strictly prohibited on the date of the examination from -09:00 AM to 05:00 PM of the examination centre and all photocopying centre will remain closed during the examination hours within the vicinity of examination centre. Accordingly I requested him pleased comply the as per order of Sub-divisional Magistrate but he denied to stop his work nor he closed the said Xerox shop, finding no other alternative to stop him, I arrested him under proper arrest memo, for violating the order U/S 144 Cr.P.C. I also seized all photo-copies from his shop and closed the shop immediately.

So, I do hereby lodge a written complaint against above mentioned person namely Ratan Pal (40Years) S/O Sri Panchanan Pal of village Hatiyari, P.O. Balageria, P.S- Marishda, Dist-Purba Medinipur for violation of Act U/S- 144 Cr.P.C for starting a case under proper section of law.
