Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Mithun Santra(user), S/O-Sri Ratan Santra Vill: Telami, P.O-Benachakri, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 25.02.2017 at about 10:20 AM, I, Sri Soumen Mondal, AE & SM, Egra CCC, along with, Sri Bikash Maity, LM Egra CCC, Sri Bappa Mondal TSH Egra CCC had been went to the Vill: Telami, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Mithun Santra(user), S/O-Sri Ratan Santra Vill: Telami, P.O- Benachakri, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Mithun Santra(user), S/O-Sri Ratan Santra Vill: Telami, P.O-Benachakri, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter by tempering the incoming service cable in respect of Consumer Id No: 223145411, Meter No: 1076215, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 6 sq mm PVC coated 2 core black colour alluminium cable allongwith by pass arrangement made by another one no 0.75 sq mm black colour PVC coated copper wire of length 3 metre each approx were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 10:40 AM.

Thus Sri Mithun Santra(user), S/O-Sri Ratan Santra Vill: Telami, P.O-Benachakri, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
