Sir,

I hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Sajal Sarkar, S/O - Lt Jaoharlal Sarkar, residing at field of Vill-Uttardaudpur, P.O.- Urdhapur, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 10.03.2017 at about 1.30 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC along with Sri Sudip Sasmal, SAE Egra CCC, Nasibat Ansary, Hg. Sr. L.M. Egra CCC had been sent to the Vill-Uttardaudpur, P.O.- Urdhapur, P.S -Egra, in your jurisdiction for the purpose of inspection. At first we went to the domestic premises of Sri Sajal Sarkar, S/O - Lt Jaoharlal Sarkar and during inspection it was found that Sajal Sarkar, was using electricity unauthorisedly by way of direct hooking from the near by LTOH line of WSEDCL used to run the domestic purpose, causing loss of revenue to WSEDCL at the time of load 0.705KVA.

Whereafter we disconnected illegal hooking arrangement from LTOH line and some portion of 2 (two) number separated single core, white and green colour PVC coated 1.5 sq mm copper conductor of length 2 (two) meter each approx along hooking arrangement were seized under memo of seizure list in presence of consumer but he & witness refused to sign. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer but he & witness refused to sign. After completion of inspection the inspection team left the aforesaid premises at 2.00 PM.

Thus, Sri Sajal Sarkar, S/O - Lt Jaoharlal Sarkar, Vill-Uttardaudpur, P.O.- Urdhapur, P.S -Egra, Dist- Purba Medinipur has committed an offence u/s 135 (i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

I am, therefore, requested to take cognizance of this complain & treat it as FIR.
