Sir,

In producing herewith arrested accused Sudhanya Panda(45) S/O-Lt. Haripada Panda of Vill+PO-Alangiri, P.S- Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Abhijit Patra of Egra P.S do hereby lodge a complaint after returning at P.S to the effect that today (11.03.17) at 05:15 hrs myself along with C/ 1631 Saroj Talukdar, C/883 Gour Ch. Ghosh and C/1102 Hikim Kiskhu all of Egra P.S vide C.C. No 394/17 dt-10.03.17 as per secret source information reached at Alangiri Bus Stand under Egra PS and held raid in the Food Shop of Sudhanya Panda(45) S/O-Lt. Haripada Panda of Vill+PO-Alangiri, P.S- Egra, Dist-Purba Medinipur and found that he was selling Foreign liquor illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed liquor. On being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized 20 (Twenty) sealed bottles of Officers Choice per bottle 180 ml x 20 = 3600 ml and each bottle Rs-100- x 20 = 2000/- (Rupees Two thousand) only as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person selling Foreign liquor illegally since long.

So, I do hereby lodge a written complaint against above mentioned Sudhanya Panda(45) S/O-Lt. Haripada Panda of Vill+PO-Alangiri, P.S- Egra, Dist-Purba Medinipur for violation U/5-46A of Bengal Excise Act.-1909 with a request for starting a case.
