Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Nirmalendu Manna, S/O- Lt Indranarayan Manna of Vill: Kiya, P.O- Bartana, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.03.2017 at about 12:30 PM, I, Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, along with Sri Soumen Mondal, AE & SM, Egra CCC, Sri Bikash Maity, LM, Egra CCC and others had been to the Vill: Kiya, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Nirmalendu Manna, S/O- Lt Indranarayan Manna of Vill: Kiya, P.O- Bartana, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Nirmalendu Manna, S/O- Lt Indranarayan Manna of Vill: Kiya, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter by tempering the incoming service cable in respect of Consumer Id No: 223120305, Meter No: B3874950, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.170 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of two core round shape black colour PVC coated 6 sq mm aluminium made tampered service cable of length one meter (approx) along with 2 nos single core blue colour PVC coated tapping PVC wire of length One and half meter each (approx) as a sample and one yellow Card vide sl no 4201980 in the name of Sri Nirmalendu Manna were seized under memo of seizure list in presence of representative of the consumer and witnesses and duly signed by them Sri Bimal Manna S/O- Lt Indranarayan Manna was present at the inspection site and acknowledged the same by putting his signature on the Seizure List, Inspection Report and label also. Thereafter the seized articles were packed and labeled at the inspection site in presence of Sri Bimal Manna S/O- Lt Indranarayan Manna and witness and signature of witnesses and Sri Bimal Manna S/O- Lt Indranarayan Manna obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:00 PM.

Thus Sri Nirmalendu Manna, S/O- Lt Indranarayan Manna of Vill: Kiya, P.O- Bartana, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
