Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Ashok Jana, S/O- Lt Natabar Jana of Vill: Kiya, P.O- Bartana, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 16.03.2017 at about 01:15 PM, I, Sri Soumen Mondal, Egra CCC, along with Sri Manas Maity, A.K.(U), (S&LP), Contal Division Office, Sri Bikash Maity, LM, Egra CCC and others had been to the Vill: Kiya, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Ashok Jana, S/O- Lt Natabar Jana of Vill: Kiya, P.O- Bartana, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Ashok Jana, S/O- Lt Natabar Jana of Vill: Kiya, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking for meter bypassing in respect of Consumer Id No: 201896354, Meter No: B3879815, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSIEDCL in the tune of load 1.170 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of two core round shape one yellow colour PVC coated 10 sq mm another one black colour PVC coated 6 sq mm aluminium conductor of length 2 (two) meter each (approx) along with hooking device as a sample were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:45 PM.

Thus Sri Ashok Jana, S/O- Lt Natabar Jana of Vill: Kiya, P.O- Bartana, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (j)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
