In producing herewith arrested accused Babu Majhi(51) S/O-Lt. Bhuteswar Majhi of Paniparul, P.S- Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I ASI Achin Niyogi of Egra P.S do hereby lodge a complaint after returning at P.S to the effect that today (19.03.17) at 10:35 hrs myself along with C/ 1244 Ashok Jana , C/151 Sk. Nazrul Hossan and C/577 Pintu Issue all of Egra P.S vide C.C. No 460/17 dt-19.03.17 as per secret source information reached at Paniparul under Egra PS and held raid in the House of Babu Majhi(51) S/O-Lt. Bhuteswar Majhi of Paniparul, P.S- Egra, Dist-Purba Medinipur and found that he was selling ID liquor illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed ID liquor on being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized 05(Five) Ltr. ID liquor per Ltr. 100 X 05=500/- (Rupees five hundred only) as per seizure list duly signed by witnesses and accused. Total cost of Rs 500/- ( Rupees Five hundred) only. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person selling ID liquor illegally since long.

So, I do hereby lodge a written complaint against above mentioned Babu Majhi(51) S/O-Lt. Bhuteswar Majhi of Paniparul, P.S- Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
