Dear Sir,

This is to draw your kind attention that the recent incident of generation of the fictitious energy bills in respect of a good number of consumers under Egra Division by showing the replacement of the energy meter in the system, with new meter by making alteration of the character of the original meter no. and changing initial reading, which is higher than that of actual meter reading and subsequent deletion of entire outstanding dues of a good number of consumers under Egra and Pataspur Customer Care Centre under Egra Division showing the same was paid in system, was thoroughly investigated by the Corporate Vigilance Cell, WBSEDCL.

It revealed in the investigation of the Corporate Vigilance Cell, WBSEDCL that Sri Soumyadip Pramanik, (S/O Sri Vivekananda Pramanik of New Town C.I. Office Lane, P.O. and P.S. Diamond Harbour, Dist: 24 Parganas (South), PIN- 743331) Office Executive presently posted at Bakrahat CCC under Behala Division (who was previously posted at Egra Customer Care Centre during the period 08.08.2010 to 31.07.2014), in collusion and connivance with one Sri Achintya Shamal (alias Kochi), S/O Jayanta Shamal of Molida, P.O. - Telami, P.S.- Egra, Dist- Purba Midnapur, not only unauthorizedly manipulated the master information of the Consumers (i.e. meter no., last reading etc.) and generated fictitious energy bills by showing the replacement of the energy meter in the system, with new meter by making alteration of the character of the original meter no. and changed initial reading in the system by breaking the system security of the SAP-ISU, causing a loss of 452751 units equivalent to an amount of Rs. 2,251,683.34/- against 68 no. consumers (out of which bills i.r.o. 16 nos. cases for 158793 units equivalent to an amount of Rs. 756320/- were regularized so far), but also made settlement of the outstanding of 27 nos. consumers under Egra and Pataspur Customer Care Centre by deleting the entire outstanding in system amounting to Rs 10,15,884/- (Rs. 8,18,396 + Rs. 1,97,488/-) by showing the same paid, by breaking the system security of the SAP-ISU for his personal gain.

The action on the part of Sri Soumyadip Pramanik, S/O Sri Vivekananda Pramanik of New Town C.I. Office Lane, P.O. and P.S. Diamond Harbour, Dist: 24 Parganas (South), PIN- 743331, being a Public Servant in the capacity of Office Executive of the Company in collusion and connivance with one Sri Achintya Shamal (alias Kochi), S/O Jayanta Shamal of Molida, P.O. - Telami, P.S.- Egra, Dist- Purba Midnapur, is tantamount to an act of breaches of integrity and trust, causing not only a loss of 452751 Units equivalent to an amount of Rs. 2,251,683.34/- against 68 no. consumers but also a loss of legitimate claim of outstanding revenue of the Company equivalent to an amount of Rs. 10,15,884/- (Rs. 8,18,396 + Rs. 1,97,488/-) by showing the same paid, by breaking the system security of the SAP-ISU, which also tarnished the very image of the WBSEDCL.
