Sir,

In producing herewith 01 (One) arrested male accused person namely Sunil Bar(50) S/O-Lt. Gunadhar Bar of Aranga, P.S- Egra, Dist-Purba Medinipur in custody under proper Memo of Arrest of seized selling Country spirit as per seizure list duly signed by witnesses and accused person. I, SI Bibek Banerjee of Egra PS do hereby lodge a complaint after returning at PS, to the effect that on 22.03.17 at 22:45 hrs myself along with C/ 1193 Dilip Kr. Bar, C/1648 Hari pada Mahanty and C/468 Sandip Maity all of Egra PS in course of Night Mobile Duty vide C.C. No-495/17 dt-22.03.17 as per secret source information reached at Aranga under Egra PS and holding raid in the House of Sunil Bar(50) S/O-Lt. Gunadhar of Aranga, P.S- Egra who was selling Country spirit illegally. On being asked he failed to produce any valid documents / license of the above mentioned possessed liquor and on being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized 10 (Ten) sealed bottles Sun Country Spirit containing per bottle 600ml x 10=6000ml and each bottle cost of Rs. 65/- x 10 =650/- (Rupees Six Hundred fifty) only with one nylon bag as per seizure list duly signed by witnesses and accused person. I arrested the above noted accused person with proper arrest rule after issuing memo of arrest. Before arrest I informed him the ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized article.

During local enquiry it could have been learnt that the above noted accused person illegally selling Country Spirit since long.

So I do hereby lodge a written complaint against above mentioned namely Sunil Bar(50) S/O-Lt. Gunadhar Bar of Aranga, P.S- Egra, Dist-Purba Medinipur for violation of Act U/S-46 A of Bengal Excise Act.-1909. Requesting O/C Egra PS for starting a case.
