Sir,

In producing herewith arrested accused Ashok Patra (55) S/O- Lt Hemanta Patra of Adlabad , Ward No 14 , P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I ASI A.K. Maity of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (25.03.17) at 19:45 hrs myself along with C/1244 Ashoke Jana, C/577 Pintu Issu and C/1276 Chandan Das all of Egra P.S vide C.C. No-517/17 dt-25.03.17 as per secret source information reached at Adlabad , Ward No 14 under Egra PS and held raid in the house of Ashok Patra (55) S/O- Lt Hemanta Patra of Adlabad , Ward No 14 , P.S Egra, Dist-Purba Medinipur and found that he was selling Foreign liquor illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed liquor. On being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized (i) 05 (Five) pcs Mc Dowells No-1 xxx Rum sealed bottle each bottle 180 ml x 05 = 900. ml and each bottle cost of Rs-90 x 5 =450/- (Rupees Four Hundred Fifty), (ii) 05 (Five) pcs Haywards 5000 super strong Beer sealed bottles each bottle 650 ml x 05 = 3250 ml and each bottle cost of Rs-100 x 5 =500/- (Rupees Five Hundred) only with one nylon bag, Total cost of Rs. 950/- (Rupees Nine hundred fifty) only as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person selling Foreign liquor illegally since long.

So, I do hereby lodge a written complaint against above mentioned Ashok Patra (55)S/O- Lt Hemanta Patra of Adlabad , Ward No 14 , P.S Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
