Sub- F.I.R

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Ajay Dhanra, S/O- Gopal Dhanra of Vill: Darbarkhanbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 05.04.2017 at about 01:20 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC, along with, Sri Bikash Maity, LM Egra CCC, Sri Bappa Mondal TSH Egra CCC had been went to the Vill: Darbarkhanbar, P.S-Egra for routine inspection purpose. At first we went to the Agricultural premises Sri Ajay Dhanra, S/O- Gopal Dhanra of Vill: Darbarkhanbar, P.O- Pirichkhanbar, P.S-Egra, Dist- Purba Medinipur and during inspection it was found that Sri Ajay Dhanra, S/O- Gopal Dhanra of Vill: Darbarkhanbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter through direct hooking from the nearby LT/HT line of WBSEDCL for his wrongfull gain to less recording the energy meter in respect of Consumer Id No: 201948394, Meter No: LPS20100, causing loss of revenue to WBSEDCL in the tune of load 4.38 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 3 (three) number separated single core two nos blue and one no white colour pvc coated 10 sq mm alluminium conductor allongwith hooking arrangement of length 2(two) metre each approx as a sample were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:00 PM.

Thus Sri Ajay Dhanra, S/O- Gopal Dhanra of Vill: Darbarkhanbar, P.O- Pirichkhanbar, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
