Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Sankar Chanda, S/O - Lt Harendra Chanda, a permanent resident of Vill-Sunia, P.O -Sipur, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 06.04.2017 at about 01:30 PM I, Sri Sudipta Rong, AE & SM, Chorepalia CCC along with Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO all are of (S&LP), Contai Division Office, Sri Raju Hazra, LM, Chorepalia CCC and others had been to the village- Sunia for routine inspection purpose. During inspection it was found that Sri Sankar Chanda was consuming electricity dishonestly in his Agricultural premises unauthorisedly by way of direct hooking through 2 (two) nos. separated single core 7/20 SWG with one blue colour and another one black colour PVC Coated aluminium conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.880 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 2 (two) nos. separated single core 7/20 SWG with one blue colour and another one black colour PVC Coated aluminium conductor of length of 3 (three) meter each approx along with hooking device as a sample used to run the electrical appliances has been seized under memo of seizure list in the presence of one available local witness and signature of witnesses i.e. representative of WBSEDCL are duly obtained in the seizure list. Sri Sankar Chanda S/O- Lt Harendra Chanda refused to sign in the Seizure List, Inspection Report. Thereafter the above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM.

Thus the accused Sri Sankar Chanda, S/O - Lt Harendra Chanda, Vill - Sunia, P.O -Sipur, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
