Sir,

In producing herewith arrested accused Kajal Das (50) W/O- Lt. Kedar Das of Kasba Egra, Ward No-06, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I ASI Achin Niyogi of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (08.04.17) at 16:30 hrs myself along with C/747 Pranajit Dey, C/1661 Dilip Dhal, NVF Sk. Rabiul, and L/C 1788 Piu Jana all of Egra P.S vide C.C. No-553/17 dt-08.04.17 as per secret source information reached at Kasba Egra near PMRC, under Egra PS and held raid in the hut of Kajal Das (50) W/O- Lt. Kedar Das of Kasba Egra, Ward No-06, P.S Egra, Dist-Purba Medinipur and found that she was selling Sun Country sprit liquor illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed liquor. On being asked the accused person stated that he is running ~~hbf~~ business since long having no valid license as well as she confessed her guilt.

Accordingly I have seized 4 (Four) sealed bottles of Sun Country Sprit per bottle 600 ml x 4 = 2400 ml and each bottle Rs-65 x 4 = 260/- (Rupees two hundred sixty) only with one nylon bag. Total cost of Rs. 260/- (Rupees two hundred sixty) only as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry it have been learnt that the above noted accused person selling Country sprit liquor illegally since long.

So, I do hereby lodge a written complaint against above mentioned Kajal Das (50) W/O- Lt. Kedar Das of Kasba Egra, Ward No-06, P.S Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act-1909 with a request for starting a case.
