I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Debashis Das, S/O – Hemanta Kumar Das, a permanent resident of Vill- & P.O.-Urdhabpur, P.S.-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 09.04.2017 at about 08.00 AM I, Sri Soumen Mondai AE & SM Egra CCC, along with Sri Sudip Sasmal, SAF (E), Egra CCC, Sri Bikash Maity, LM, Egra CCC, Subhas Chandra Das, Gr-I, TSH and others had been to the village-Urdhabpur under PS Egra for routine inspection purpose. During inspection it was found that Sri Debashis Das, S/O – Hemanta Kumar Das was consuming electricity dishonestly in his Agricultural premises unauthorisedly by way of direct hooking through 10 SWG fade red coloured PVC coated aluminium conductor from of unauthorised installed 16 KVA 11/0.4 KV Distribution Transformer from the HTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 11.17 KVA.

As theft of electricity was detected during the inspection the 11 KV OH line are taken shutdown and thereafter the illegal, hooking wire were disconnected & removed from HTOH of WBSEDCL and some portion of 3 (three) number separated single core 10 sq mm fade red colour PVC coated aluminium conductor of length 2 (two) meter each approx as a sample alongwith hooking device were seized under memo of seizure list in presence of consumer who refused to sign and available witnesses duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer who refused to sign available witnesses duly signed by them. After completion of inspection the inspection team left the aforesaid premises at 08.30 AM.

Thus the accused Sri Debashis Das, S/O – Hemanta Kumar Das, a permanent resident of Vill- & P.O –Urdhabpur, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.
