Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Chandan Jana, S/O- Lt Haripada Jana of Vill: Bhatda, P.O- Bhatda, P.S Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 11.04.2017 at about 12:15 PM, I, Sri Sudip Sasmal, SAE(E) & SM, Egra CCC, along with, Sri Nasibat Ansari Hg. Sr, LM Egra CCC, Sri Bikash Maity, LM Egra CCC, had been went to the Vill: Bhatda, P.S-Egra for routine inspection purpose. At first we went to the Agricultural premises Sri Chandan Jana, S/O- Lt Haripada Jana of Vill: Bhatda, P.O- Bhatda, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Chandan Jana, S/O- Lt Haripada Jana of Vill: Bhatda, P.O- Bhatda, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter by the incoming terminal of energy meter in respect of Consumer Id No: 201948438, Meter No. LF520301, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 4.38 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 3 (three) number separated single core PVC coated red colour 10 sq mm aluminium conductor alongwith by pass arrangement of length 2(two) metre each approx as a sample were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 12:45 PM.

Thus Sri Chandan Jana, S/O- Lt Haripada Jana of Vill: Bhatda, P.O- Bhatda, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.
