Sir,

In producing herewith 01 (One) arrested male accused person namely Sunil Jana(58) S/O-Lt. Prafullya Jana of Vill+PO-Jumki, P.S- Egra Dist-Purba Medinipur in custody under proper Memo of Arrest of seized Sun Country Spirit as per seizure list duly signed by witnesses and accused person. I, SI Bibek Banerjee of Egra PS do hereby lodge a complaint as Suo - moto after returning at PS, to the effect that today (16.01.17) at 19:05 hrs myself along with C/ 883 Gour Ch. Ghosh, C/1193 Dillip Kr. Bar and NVP SK Ekram all of Egra PS in course of Evening Mobile Duty vide C.C. No-122/17 dt-16.01.17 as per secret source information reached at Jumki under Egra PS and holding raid in the house of namely Sunil Jana who was selling Sun Country Sprite illegally. On being asked he failed to produce any valid documents / license of the above mentioned possessed liquor and on being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I seized Sun Country Sprite 06 (Six) sealed bottles per bottle 600 ml x 06 = 3600 ml and each bottle Rs-55/- x 06 =330/- (Rupees Three Hundred thirty) only as per seizure list duly signed by witnesses and accused person. I arrested the above noted accused person with proper arrest rule after issuing memo of arrest. Before arrest I informed him the ground of arrest and took his signature in the arrest Memo and seizure list. I also prepared label and sample of seized articles.

During local enquiry it could have been learnt that the above noted accused person illegally selling Sun Country Sprite since long.

So I do hereby lodge a written complaint against above mentioned namely Sunil Jana S/O-Lt. Prafullya Jana of Vill+PO-Jumki, P.S-Egra, Dist-Purba Medinipur for violation of Act U/S-46 A of Bengal Excise Act.-1909. Requesting O/C Egra PS for starting a case.
