I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Gokul Pradhan, S/O - Rashbehari Pradhan, a permanent resident of Vill-Utabad & P.O -Kautgeria, P.S -Egra, Dist- Purba Medinipur and his son namely Muktipada Pradhan have committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 19.04.2017 at about 05.30 PM I, Sri Soumen Mondal, AE & SM, Egra CCC, along with Sri Sudip Sasmal, SAE (E), Egra CCC, Sri Bappa Mondal, TSH, Egra CCC and others had been to the village-Ultabad under PS Egra for routine inspection purpose. During inspection it was found that Sri Gokul Pradhan, S/O - Rashbehari Pradhan was consuming electricity dishonestly in his domestic premises unauthorisedly by way of direct hooking through 1.5 sq mm black coloured PVC coated copper conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 1.00 KVA. Firstly Sri Gokul Pradhan & his son namely Muktipada Pradhan protest our official duty and force fully stay in his premises to eliminate the hooking arrangement. After that we conduct the Egra Police Station via phone to rescue from his premises. Police personals came to site and rescue us to from the his premises.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 01 (one) number 1.5 sq mm black coloured PVC coated aluminium conductor of length 02 (two) meter (approx) along with hooking device as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Gokul Pradhan, S/O - Rashbehari Pradhan and his son namely Muktipada Pradhan acknowledged the the same but refused to sign in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative has been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 7.30 PM.

Thus the accused Sri Gokul Pradhan, S/O - Rashbehari Pradhan, a permanent resident of Vill-Ultabad & P.O -Kautgeria, P.S -Egra, Dist- Purba Medinipur and his son namely Muktipada Pradhan have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR under proper section of law.
