Sir,

In producing herewith arrested accused Sanatan Jana (38) S/O Kanailal Jana of Khajurda, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Abhijit Patra of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (19.04.17) at 22:35 hrs myself along with C/1141 Bharat Ch. Ghosh, C/1244 Ashok Kr. Jana, 1631 Soraj Talukdar all of Egra P.S vide C.C. No-674/17 dt-19.04.17 as per secret source information reached at Dhobandhi Bazar under Egra PS and held raid at the tea stall of Sanatan Jana (38) S/O Kanailal Jana of Khajurda, P.S Egra, Dist-Purba Medinipur and found that he was selling Foreign liquor and country Spirit illegally. On being asked he failed to produce any valid documents/ license of the above mentioned possessed Foreign liquor. On being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly seized (i) 05 (Five) sealed bottles of Haywards 5000 super strong Beer each bottles 650 ml and each bottle cost of Rs-100 x 05 =500 /- (Rupees Five Hundred) only (ii) 05 (Five) sealed bottles of Sun country Spirit each bottle contains 600 ml and each bottle cost of Rs-65 x 05 = Rs 325/- (Rupees Three Hundred twenty five) only with one Nylon Bag. Total value of Foreign Liquor and country Spirit total cost of Rs. 825/- (Rupees Eight Hundred twenty five) only as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry I have been learnt that the above noted accused person selling Foreign liquor illegally since long.

So, I do hereby lodge a written complaint against above mentioned Sanatan Jana (38) S/O Kanailal Jana of Khajurda, P.S Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
