

In production here with the arrested accused persons namely (1)Pintu Patra(39) S/O-Lt. Laxmikanta Patra of Mahanagar, PS-Egra, Dist-Purba medinipur (2)Haripada Das(40) S/O-Madhusudan Das of Krishnapur, PS-Egra, Dist-Purba Medinipur (3)Badal Giri(48) S/O-Haripada Giri of Uttar Tajpur, PS-Egra, Dist-Purba Medinipur (4)Gorachand Pramanik (29) S/O-Lt. Paresh Pramanik of Rautara, PS-Contal, Dist-Purba Medinipur (5)Bablu Jana(48) S/O-Jibankrishna Jana of Sunbhari, PS-Egra, Dist-Purba Medinipur (6)Makhanlal Mondal(51) S/O-Lt. Ganesh Mondal of Bidurpur, PS-Egra, Dist-Purba Medinipur with seizure list and selzed articles along with arrest memo. I beg to submit complain to the effect that today(24.04.17) at about 11.45 hrs received a source information regarding playing card in exchange money illegally,accordingly I inform O/C Egra PS and as per his order myself with C/883 Gour Ch. Ghosh, C/842 Abdul Khalek Khan & NVF-Sk Rabiul Hossion all of Egra PS left for Uttar Tajpur, PS-Egra to workout the information after diarizing same vide Egra PS C.C No-712/17 dt-24.04.17 we arrived at Uttar Tajpur temporary house of Ratan Singh S/O-Basanta Singh of Sahapur, PS-Egra, Dist-Purba Medinipur and showed by the source in a distance we found that 10 to 12 person were inside the temporary house were engaged in playing to each other in exchange of money in a view to wrongful loss to other and wrongful gain to another.

We hold raid and apprehended 06(six) persons and other 03/04 persons managed to flew away through paddy field, during searched I seized the following articles from the Grambling board and adjacent to PO which was selzed under proper seizure list duly singed by witnesses and accused persons I label its properly on interrogation they disclosed there identity [1]Pintu Patra(39) 5/0-Lt. Laxmikanta Patra of Mahanagar, PS-Egra, Dist-Purba medinipur (2)Haripada Das(40) S/O-Madhusudan Das of Krishnapur, PS-Egra, Dist-Purba Medinipur (3)Badal Giri(48) S/O-Haripada Giri of Uttar Tajpur, PS-Egra, Dist-Purba Medinipur (4)Gorachand Pramanik (29) S/O-Lt. Paresh Pramanik of Rautara, PS-Contal, Dist-Purba Medinipur (5)Bablu Jana(48) S/O-Jibankrishna Jana of Sunbhari, PS-Egra, Dist-Purba Medinipur (6)Makhanlal Mondal(\$1) S/O-Lt. Ganesh Mondal of Bidurpur, PS-Egra, Dist-Purba Medinipur and they con faced that they were playing cards in exchange money and they also confessed that one Ratan Singh S/O-Basanta of Sahapur, PS Egra, Dist Purba Medinipur is running the Grambling board inside of his temporary new constructed house during raid Ratan Singh along with other manage to flew away the arrested persons also confessed that they were came to Grambling board for playing cards by there motor cycle etc. I seized the following articles proper seizure list and (01)156 of playing cards(02),01 plastic old and use,(03)05 pieces old news paper, (04)20pieces burn Biri, (05)01 Emergency light, (06) 03 Motor cycle bearing No-WB30E 3424(Hero Honda),WB 32A 8491 (Pulser),WB 01W 6929 (Honda) and 01 without Number Honda Motor cycle Chassis No. ME4KC236MG8002904 and engine No. KC23E80118895.(07)Board.money Cash Rs 25450/-(Twenty five thousand four hundred fifty rupees only) arrested them after issuing there memo of arrest and inform them ground of arrest.

Thus they violated the provision of section 3 & 4 WBG and PC Act and liable to prosecute and made them same section of law.

Hence a specific case may kindly be started U/S 3 & 4 WBG and PC Act against the above noted accused persons and Ratan Singh S/O-Basanta Singh of Sahapur, PS-Egra, Dist-Purba Medinipur.
