I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Dhiren Bera, S/O - Lt Sashibhusan Bera, a permanent resident of Vill-Khalina, P.O -Bartana, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 27.04.2017 at about 12:00 PM (noon) I, Sri Soumen Mondal, AE & SM Egra CCC along with Sri Manas Maity, AE (U), S&LP, Contai Division office, Sri Bikash Maity, LM, Egra CCC, Sri Bappa Mondal, TSH, Egra CCC and others had been to the village- Khalina for routine inspection purpose. During inspection it was found that Sri Dhiren Bera was consuming electricity dishonestly in his Domestic premises unauthorisedly by way of direct hooking through 01 (one) number single core 2.5 sq mm black coloured PVC coated aluminium conductor from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.5 KW.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 01 (one) number single core 2.5 sq mm black coloured PVC coated aluminium conductor of length 02 (two) meter (approx) along with hooking device as a sample has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Dhiren Bera refused to on the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 12:15 PM.

Thus the accused Sri Dhiren Bera, S/O - Lt Sashibhusan Bera, Vill - Khalina, P.O -Bartana, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135 (i) (a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR. The F.I.R is typed by me.
