Sir,

In producing herewith arrested accused Kalicharan Jana(56) S/O-Lt. Purna Chandra Jana of Dhusurda, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I ASI Asim Kr. Maity of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (08.05.17) at 07:05 hrs myself along with C/1193 Dilip Kr. Bar, C/577 Pintu Issu, NVF-Kalachand Jana all of Egra P.S vide C.C. No-948/17 dt-08.05.17 as per secret source information reached at Dhusurda under Egra PS and held raid in the house of Kalicharan Jana(56) S/O-Lt. Purna Chandra Jana of Dhusurda, PS Egra, Dist-Purba Medinipur and found that he was selling Country spirit illegally. On being asked he failed to produce any valid documents/license of the above mentioned possessed liquor. On being asked the accused person stated that he is running his business since long having no valid license as well as he confessed his guilt.

Accordingly I have seized 08 (Eight) sealed bottles of Sun Country Spirit per bottle 600 ml x 08=4800 ml and each bottle cost of Rs-65 x 08 =520/- (Rupees Five hundred Twenty) only with one nylon bag as per seizure list duly signed by witnesses and accused person. I also prepared label.

During local enquiry it have been learnt that the above noted accused person selling Country spirit illegally since long.

So, I do hereby lodge a written complaint against above mentioned Kalicharan Jana(56) S/O-Lt. Purna Chandra Jana of Dhusurda, PS-Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
