Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Gobinda Mondal S/O- Lt Barendranath Mondal of Vill: Dubda, P.O- Dubda, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 11.05.2017 at about 12:40 PM, I, Sri Soumen Mondal, AE & SM, Egra CCC, along with, Sri Bilashy Mani, LM Egra CCC, Bappa Mondal, TSH Egra CCC had been went to the Vill: Dubda, P.S-Egra for routine inspection purpose. At first we went to the Agricultural premises of Sri Gobinda Mondal S/O- Lt Barendranath Mondal of Vill: Dubda, P.O- Dubda, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Gobinda Mondal S/O- Lt Barendranath Mondal Pradhan of Vill: Dubda, P.O- Dubda, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of bypassing the energy meter through direct hooking from the incoming terminal of energy meter in respect of Consumer Id No: 201484223, Meter No: GX016716, in view of less recording of unit or energy in the energy meter, causing loss of revenue to WBSEDCL in the tune of load 6.58 KVA

As theft of electricity was detected during the inspection the service connection was disconnected from the LT bushing of DTR and some portion of 3 (three) number separated single core one green one black and one white colour PVC coated 10 sqmm alluminium conductor along with hooking arrangement of length 2(two) metre each approx were seized under memo of seizure in presence of consumer but he refused to sign, and witnesses duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness. Signature of witnesses and consumer but he refused to sign, obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:10 PM.

Thus Sri Gobinda Mondal S/O- Lt Barendranath Mondal of Vill: Dubda, P.O- Dubda, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
