Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Srikumar Maity, S/O- Narayan Ch Maity of Vill: Shilampur, P.O- Pirijkhanbar, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 12.05.2017 at about 01:00 PM, I, Sri Manas Maity, A.E.(U), (S&LP), Contai Division Office, along with Sri Soumen Mondal, AE & SM, Egra CCC, Sri Bappa Mondal, TSH, Egra CCC and others had been to the Vill: Shilampur, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Srikumar Maity, S/O- Narayan Ch Maity of Vill: Shilampur, P.O- Pirijkhanbar, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Srikumar Maity, S/O- Narayan Ch Maity of Vill: Shilampur under P.S-Egra consuming electricity unauthorisedly by way of direct hooking for meter bypassing through single core black colour PVC coated telephone cable (copper conductor) in respect of Consumer Id No: 201892889, Meter No: B4022004, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 1.17 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of single core black colour PVC coated telephone cable (copper conductor) of length 1 (one) meter (approx) along with hooking device as a sample and one yellow card vide Sl No- 0154059 in the name of Sri Srikumar Maity were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 01:30 PM.

Thus Sri Srikumar Maity, S/O- Narayan Ch Maity of Vill: Shilampur, P.O- Pirijkhanbar, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
