Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Shib Sankar Jana (User), S/O- Lt Sunil Jana of Vill: Silampur, P.O- Pirijkanbar, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 12.05.2017 at about 01:40 PM, I, Sri Soumen Mondal, Egra CCC, along with Sri Sudip Sasmal, SAE (E), Egra CCC, Sri Bikash Maity, LM, Egra CCC and others had been to the Vill: Silampur, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Shib Sankar Jana (User), S/O- Lt Sunil Jana of Vill: Silampur, P.O- Pirijkanbar, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Shib Sankar Jana (User), S/O- Lt Sunil Jana of Vill: Silampur under P.S-Egra consuming electricity unauthorisedly by way of bypassing the energy meter by tempering the incoming service cable in respect of Consumer Id No: 223126815. Meter No: G039536 which is in the name of Sunil Jana S/O- Lt Surendranath Maity, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL, in the tune of load 0.660 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of 2 core black colour PVC coated 6 sq mm tampered service cable made of aluminium of length 1 (one) meter (approx) along with bypass arrangement made by another 2 nos blue colour PVC coated 1.5 sq mm copper conductor of length 2 meter each (approx) as a sample were seized under memo of seizure list in presence of representative of the consumer i.e. Smt. Rebati Jana W/O- Sri Shib Sankar Jana and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of Smt. Rebati Jana W/O- Sri Shib Sankar Jana and witness and signature of witnesses and representative of consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:10 PM.

Thus Sri Shib Sankar Jana (User), S/O- Lt Sunil Jana of Vill: Silampur, P.O- Pirijkanbar, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
