Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Tapan Chowdhury, S/O - Lt Binoy Chowdhury, a permanent resident of Vill-Negua, P.O -Negua, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 12.05.2019 at about 5:30:00 PM I, Sri Sudipta Rong, AE & SM, Chorepalia CCC along with Sri Joydeep Mitra, OE, Sri Partha Ghosh, TSH,Chorepalia CCC all are staffs of OE, Chorepalia CCC and others had been to the village- Negua for routine inspection purpose. During inspection it was found that Sri Tapan Chowdhury was consuming electricity dishonestly in his Commercial premises consuming electricity unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 0.15 KW.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of single core 02 no's 2.5 sq mm blue & red colour PVC coated aluminium conductor of length 05 meter each approx along with hooking arrangement as a sample used to run the electrical appliances for Commercial purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 6:00:00 PM.

Thus the accused Sri Tapan Chowdhury, S/O - Lt Binoy Chowdhury, Vill - Negua, P.O -Negua, , P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
