Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Milan Das, S/O - Lt Ramchandra Das, a permanent resident of Vill-Gopinathpur, P.O -Telami, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 12.05.2017 at about 4:00:00 PM I, Sri Sudipta Rong, AE & SM, Chorepalia CCC along with Sri Joydeep Mitra, OE, Sri Partha Ghosh, TSH all are staffs of Chorepalia CCC and others had been to the village- Gopinathpur for routine inspection purpose. During inspection it was found that Sri Milan Das was consuming electricity dishonestly in his Domestic premises consuming electricity unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 02 KW.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of 02 core 04 sq mm flexible PVC cable of length 2.5 Mtr approx along with hooking arrangement as a sample used to run the electrical appliances for Domestic purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Milan Das acknowledged the same by putting his signature in the Label, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the representative of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 4:25:00 PM.

Thus the accused Sri Milan Das, S/O - Lt Ramchandra Das, Vill - Gopinathpur, P.O -Telami, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
