Sir,

In producing herewith arrested accused Mani Murmu(40)W/O-Lt. Laxman Murmu of Kasba Egra, Ward No-05, P.S Egra, Dist-Purba Medinipur and the following seized articles as per seizure list. I SI Deb Prasad Samanta of Egra PS do hereby lodge a complaint after returning at P.S to the effect that today (16.05.17) at 14:45 hrs myself along with C/1141Bharat Ch. Ghosh, C/1244 Ashok Jana, NVF Sk. Ekram, L/C 386 Mousumi Mishra all of Egra P.S vide C.C. No-1022/17 dt-16.05.17 as per secret source information reached at Kasba Egra under Egra PS and held raid in the house of Mani Murmu(40)W/O-Lt. Laxman Murmu of Kasba Egra, Ward No-05, P.S Egra, Dist-Purba Medinipur and found that She is selling country Spirit illegally. On being asked she failed to produce any valid documents/ license of the above mentioned possessed Country Spirit . On being asked the accused person stated that She is running this business since long having no valid license as well as She confessed her guilt.

Accordingly seized 05 (five) sealed bottles of Sun country Spirit each bottle contains 600 ml x 05=3000 ml and each bottle cost of Rs-65 x 05 = Rs 325/- (Rupees Three Hundred twenty five) only with one Nylon Bag as per seizure list duly signed by witnesses and accused person. I also prepared label and sample of seized articles.

During local enquiry I have been learnt that the above noted accused person selling Country Spirit illegally since long.

So, I do hereby lodge a written complaint against above mentioned Mani Murmu(40)W/O-Lt. Laxman Murmu of Kasba Egra, Ward No-05, P.S Egra, Dist-Purba Medinipur for violation U/S-46A of Bengal Excise Act.-1909 with a request for starting a case.
