Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Nandan Pradhan, S/O - Kshudiram Pradhan, a permanent resident of Vill-Aranga, P.O -Aranga Kultikri, P.S -Egra, Dist- Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 19.05.2017 at about 01:30 PM I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO all are of (S&LP) unit Contai Division Office along with Sri Ratan Bhunia, SAE (E), Chorepalia CCC, Sri Joydeep Mitra, OE, Chorepalia CCC and others had been to the village- Aranga for routine inspection purpose. During inspection it was found that Sri Nandan Pradhan was consuming electricity dishonestly in his Commercial (Grocery Shop) premises unauthorisedly by way of direct hooking from the nearby LTOH line of WBSEDCL, causing considerable loss of revenue of WBSEDCL to the tune of load 1.170 KVA.

As theft of electricity was detected during inspection the illegal hooking line was disconnected & removed from the nearby electrical source and some portion of single core 02 no's 2.5 sq mm yellow & green colour jointed PVC coated copper conductor of length 04 meter each approx along with hooking arrangement as a sample used to run the electrical appliances for Commercial purpose has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Nandan Pradhan acknowledged the same by putting his signature in the Seizure List, Inspection Report. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as of the accused has also been obtained on the label. After completion of inspection, the inspection team left the aforesaid premises at about 02:00 PM.

Thus the accused Sri Nandan Pradhan, S/O - Kshudiram Pradhan, Vill - Aranga, P.O -Aranga Kultikri, P.S -Egra, Dist- Purba Medinipur have committed an offence u/s 135(i)(a) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR.
