Dear Sir,

I do hereby lodge a written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 against Sri Panchanan Manna, S/O- Sripati Manna of Vill: & P.O- Paniparul, P.S-Egra, Dist-Purba Medinipur has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated here under.

On 19.05.2017 at about 02:15 PM, I, Sri Manas Maity, A.E.(U), Sri Pradip Kr. Chakraborty, SO all are of (S&LP) unit Contai Division Office along with Sri Ratan Bhunia, SAE (E), Chorepalia CCC, Sri Joydeep Mitra, OE, Chorepalia CCC and others had been to the Vill: Paniparul, P.S-Egra for routine inspection purpose. At first we went to the Domestic premises Sri Panchanan Manna, S/O- Sripati Manna of Vill: & P.O- Paniparul, P.S-Egra, Dist-Purba Medinipur and during inspection it was found that Sri Panchanan Manna, S/O- Sripati Manna of Vill: Paniparul, P.S-Egra, Dist-Purba Medinipur consuming electricity unauthorisedly by way of direct hooking for meter by-passing through 4 sq mm blue colour PVC coated aluminium conductor in respect of Consumer Id No: 200314775, Meter No: BR568690, in view of less recording of unit or energy in to the energy meter, causing loss of revenue to WBSEDCL in the tune of load 0.750 KVA.

As theft of electricity was detected during the inspection the service connection was disconnected from pole and some portion of single core 02 no's 4 sq mm blue colour PVC coated aluminium conductor of length 05 meter each approx along with hooking arrangement as a sample used to run the electrical appliances for domestic purpose were seized under memo of seizure list in presence of consumer and witnesses and duly signed by them. Thereafter the seized articles were packed and labeled at the inspection site in presence of consumer and witness and signature of witnesses and consumer obtained on the label. After completion of inspection the inspection team left the aforesaid premises at 02:45 PM.

Thus Sri Panchanan Manna, S/O- Sripati Manna of Vill: Paniparul, P.O- Paniparul, P.S-Egra, Dist-Purba Medinipur has committed an offence u/s 135 (i)(b) of the Electricity Act 2003 read with Amendment Act 2007.

So you are requested to take cognizance of this complain treating it as FIR.
